# **Governmental Affairs: News from the Hill**

hope your summer has been all that you were hoping it would be! I have heard numerous sighs of relief from friends, family, and colleagues of the impending return of

their children to school in the very near future. I suppose this signals a return to some sort of normalcy and routine in family life! Oh that we could be so lucky on the legislative front!

It is a busy time on the national front due to the debate on health care reform. I hope that all of you have been keeping an eye on the discussion from national committees to the highly reported "town hall meetings" that are being held all over the nation. It is no secret that some sort of health care reform is needed, but the biggest secret is exactly how it will occur and how it will be funded. I will include a number of web sites in this report for you to access so that you can monitor this important debate. It is my strongest hope that you will all become involved on some level of this important discussion and maintain contact with your Senators and Representatives. They need to know your thoughts about what you desire to see included, or not included, in the final bill that will govern health care for the lives of so many for years to come.

The Texas 81st Legislative Session was also very busy. It ended with ~7000 bills presented. The good news is that it was a good session for nursing! You will see the results of some of that legislation later in this report. There were

some strong protections added for nurses in this session. SB 476/HB 591, <u>Safe Hospital Staffing</u>, should go to Governor Perry for his signature in September.

It has been a privilege this year to work with our ASPAN GAC Chair, David Kay. He has spent many hours sending information about legislation and other information to those of us on the Governmental Affairs Committee. I hope you have received much of the information as I send it to key people in TAPAN to disseminate to our membership. I have included the summarized first quarter report from our new ASPAN President, Terry Clifford, about the progress from the ASPAN Governmental Affairs Committee in an effort to keep you apprised of the work done at the national level of our organization:

"Governmental Affairs Committee continues involvement with the American Nurses Shortage Relief Alliance (ANSR) (G. Near)

- ASPAN signed on with other nursing organizations to seek House and Senate support of President Obama's FY 2010 budget proposal for the Nursing Workforce Development programs authorized under Title VIII of the Public Health Service Act.
- ASPAN commended the work of the House Tri-Committee on the Health Reform Draft Proposal along with other nursing organi-

- zations (The Tri-Committee recognizes the fundamental need for accessible quality care and understands the contribution nurses will make to ensure the provisions of the bill are implemented).
- ASPAN supported the Nursing Community development of a brochure highlighting "Nursing Workforce Development Programs" in response to Title VIII of the Public Health Service Act (The Nursing Community is a forum for professional nursing and related organizations to collaborate on a wide spectrum of health care and nursing issues including practice, education, and research.
- ASPAN supported Senators who proposed the Nurses' Higher Education and Loan Repayment Act of 2009.
- ASPAN supported Senators who crafted the Affordable Health Choices Act of 2009."

#### **National News:**

President Barack Obama signed the Family Smoking Prevention and To-bacco Control Act into law on June 22nd. The American Nurses Association (ANA) applauds both President Obama and Congress for enacting legislation that allows the Food and Drug Administration (FDA) to regulate cigarettes and other tobacco products. The Family Smoking Prevention and Tobacco Control Act gives new oversight authority to the

FDA in regulating how the tobacco industry manufactures and markets products.

The Family Smoking Prevention and Tobacco Control Act allows the Food and Drug Administration to regulate the advertising, marketing, and manufacturing of tobacco products under the Federal Food, Drug, and Cosmetic Act. ANA believes that patient education and interventions to stop tobacco use should be central to good nursing practice. Prevention is key in reducing the number of youth who begin smoking every day. This bill would also grant the FDA the authority to prevent the marketing and sales of tobacco to kids. A healthy and safe environment, free of tobacco smoke, is a national public health priority.

Rachel Conant Capital Update, Vol. 7/Issue 4, July 2009

Seven states (CT, IL, NV, OH, OR, TX, WA) have legislated staffing committees in which staff nurses are empowered to establish staffing plans specific to unit and shift needs in collaboration with management. As a condition of licensing, Nevada's new law requires that health care facilities (hospitals in counties with a population of 100,000 more and greater than 70 beds) establish a staffing committee comprised of 50 percent direct care nurses who will develop staffing plans. It is expected that plans will be flexible enough to accommodate for changes in patients, staff, unit design, and technology. The experience of this new law will be summarized in a written report submitted to the Director of the Legislative Counsel Bureau (even years) and the Legislative Committee on Healthcare (odd years). Similarly, Texas will establish a staffing committee to direct policy and devise a staffing plan for each unit, with one half of the membership required to be direct care nurses. Texas' law also includes provisions for whistleblower protections and mandatory overtime.

Capital Update, Vol 7/Issue 4, July 2009

"Wonderful news for nursing! President Obama's FY 2010 Budget Request proposes \$263 million for the Title VIII Nursing Workforce Development Programs. Should this level pass Congress, it will be the highest level of appropriations since the programs were created in 1964. The two programs to receive increases over FY 2009 levels are the Nurse Loan Repayment and Scholarship program (\$125 million, a 238% increase) and the Nurse Faculty Loan Program (\$16 million, a 39% increase). #### **State News:**

"Legislation supported by Texas Nurses Association (TNA) and Texas Hospital Association (THA) was filed on the second day of the 81st Legislative Session that was proposed to give direct patient care nurses in Texas a stronger voice in setting appropriate nurse-to-patient staffing levels at their hospitals. Senate Bill 476 was authored by Sen. Jane Nelson (R-Flower Mound), chair of the Senate Committee on Health and Human Ser-Its companion bill in the vices. House, H.B. 591, was co-authored by Rep. Donna Howard (D-Austin), a former critical care nurse, and Susan King, RN (R-Abilene)." (TNA announcement 1/14/09). I was fortunate to hear the Senate testimony regarding this bill when I was in Austin during Nurse Day at the Capital. The TNA representatives were concise and organized in their testimony about how crucial this bill would be to nursing. It was the first time I had the opportunity to be in this type of setting. As of June, it looked as if nursing had a good legislative session. Most of the nursing-initiated legislation passed. There are a few disappointments (APN and sovereign immunity), but on the whole it appears to have been a good session.

SB 476, Nurse Staffing Bill, passed. The bill passed without any discussions or amendments. Apparently, Rep. Thompson had amendments drafted to file on behalf of CNA/NNOC but decided to withdraw those amendments. It is unknown what was in the amendments. Bottom line is the bill passed without any amendments or

anyone speaking against it. The bill went back to the Senate for Sen. Nelson to concur in the technical clean-up changes that were made in House Public Health Committee.

SB 1415 giving BON more options in addressing minor violations. SB 1415 has passed and been sent to the Governor for his signature.

HB 3961, omnibus bill addressing nursing regulation. HB 3961 is on Senate Local & Uncontested Calendar for Thursday. The bill still includes the agreement reached on the Excelsior College issue.

Nursing Shortage Funding. The appropriations bill is in final stages and it looks like nursing schools will get \$30 million in new funding plus the existing \$15 million for a total of \$45 million.

Advanced Practice. This is one of the disappointments, but it was not unexpected. SB 532 (TMA/convenient clinic negotiated bill) passed. Floor amendments improved the bill to address charity/disaster clinics and to increase the number of APNs/per physician from 3 to 4. Attempts to add the two APN-initiated bills (autonomous practice and prescriptive authority agreement model) were unsuccessful.

SB 2719, Waiver of sovereign immunity. Waiver of sovereign immunity for publicly-employed nurses was withdrawn from House Local and Consent Calendar due to objections from Texas Conservative Coalition. It did not pass this session.

A re you due to recertify this fall?? ABPANC is implementing a new Online Recertification System. CPAN and CAPA certified nurses will use this system to:

- → Submit an application to recertify their certification status through the Continual Learning Program (through contact hours);
- ★ Create an online certification account;
- ✦ Review, update and edit their Certificant Profile information; and keep track of and log their contact hours during their three year certification period through ABPANC's Electronic Filing Cabinet.

While the *process* for recertifying will be different, the Continual Learning Program (through contact hours) is unchanged. The window for recertifying online in the Fall 2009 began at midnight, August 1 and runs through 11:59 pm October 31. Certification status expires on November 1.

Good luck to everyone who has accepted the challenge to take either the CPAN or CAPA exam this fall. The final deadline for registering for the exam is September 21st. 

# **District Chapter Formation: TAPAN Introduces Newest Policy**

uring the June and August TAPAN Executive Board meetings, the Board addressed chapter formation. While chapters are not a new concept, TAPAN's process for establishing a chapter was never specifically articulated. A policy addressing that gap was drafted and introduced in June. It was finalized and approved at the August Board meeting. The policy establishes guidelines for formal recognition of perianesthesia nurses who want to meet in a specified geographic area within a TAPAN district. Board members believe these guidelines could revitalize activities at the local level. We hope local chapters will also promote opportunities for fellowship and community involvement.

Basic prerequisites for chapter formation include the following:

- Application to the TAPAN Board by the District President;
- Designation of a Chapter Chairperson;
- A minimum of 5 active TAPAN members in the proposed location;
- A minimum of 2 Chapter meetings per year;
- Proposed location must be 30 miles or more from the District headquarters\*; and

Chapters may apply for renewal every 3 years.

TAPAN districts are struggling to keep members involved. There are a variety of reasons including time, distance and a lack of candidates to fill district offices. Some of the original TAPAN districts are no longer active. The Board committed to constructive solutions. Chapter formation is one step. Incoming President, Susan Norris, anticipates additional reorganization and revitalization of TAPAN Districts during the coming year.

TAPAN's Bylaws require that policies and procedures be reviewed every three years. At each Executive Board meeting, time is set aside for this purpose. New policies are written to meet the changing needs of the organization. The Bylaws are available for review on the TAPAN website. Each district receives a current copy of the TAPAN Policies and Procedures at the Annual State Conference. This year, the 2009-2010 TAPAN Policies and Procedures will be distributed in electronic format to each District President at the District Officers Meeting held during the Annual Conference. Additional information regarding chapter formation will be available during that meeting. All district officers are encouraged to attend. All interested TAPAN members may attend. Board members will be present to answer your questions regarding chapter formation or any other TAPAN Policy. **♦**

#### **ABPANC Seeks Nominations for Board of Directors**


A BPANC is accepting nominations for RN Director positions for the 2010-2012 terms of office. The term of office on the Board of Directors is two years.
